

Amendments to the Constitution

Rule Number 13.(1) has been changed to read as follows:

Subject in the case of the first members of the committee to Section 21 of the Act, the executive committee,

- (i) in the event the school is run as a single session in one location, shall consist of –
- (a) the office bearers of the centre; and
 - (b) seven ordinary members, each of whom except referred in clause 3, shall be elected at the annual general meeting of the Centre every year.
- (ii) in the event the school is run as two sessions in one location or in two separate locations, shall consist of –
- (a) the office bearers of the centre; and
 - (b) six ordinary members, each of whom except referred in clause 3, shall be elected at the annual general meeting of the Centre every year.

Rule Number 13.(2) has been changed to read as follows:

(i) In the event the school is run as a single session in one location, the office-bearers of the Centre shall be the following eight members:

- (a) the president;
- (b) the vice-president;
- (c) the treasurer;
- (d) the assistant treasurer;
- (e) the secretary;
- (f) the assistant secretary;
- (g) the principal; and
- (h) the vice-principal.

(ii) In the event the school is run as two sessions in one location or in two separate locations, the office-bearers of the Centre shall be the following twelve members:

- (a) the president;
- (b) two vice-presidents;
- (c) the treasurer;
- (d) two assistant treasurers;
- (e) the secretary;
- (f) two assistant secretaries;
- (g) the principal; and
- (h) two vice-principals

Rule Number 2.(2) has been changed to read as follows:

Location shall be Darcy Road Public School, Darcy Road, Wentworthville, NSW 2145 and Girraween Public School, Bando Road, Girraween, NSW 2145 (as the second campus of WTSC).

Rule Number 2.(3) has been changed to read as follows:

Mailing address of the Centre shall be P.O.Box 557, Wentworthville, NSW 2145 or as nominated by the executive committee in the event of any change in this address.
