permit a person to act as a volunteer without a WWCC clearance, provided that: (i) the volunteer acts at all times under the supervision of a member of the Executive Committee who is holding a current and valid WWCC; and (ii) the nature, scope, and duration of the volunteer activity are limited as determined by the Executive Committee. 19.(18) All individuals whose involvement with the centre requires them to work with or access any data and/or personal information held by the Centre shall be required to read, understand, and formally sign the Wentworthville Tamil Study Centre's Privacy and Data Access Policy prior to undertaking any such duties.
